

2022 YHFS ARCP Timetable for FY1s to obtain Full Registration with the GMC

LOCAL ARCP - TRUST

By Friday 27th May 2022

- Educational Supervisors to complete End of Year Report.
- **Foundation Trainees** to complete Foundation Form R as part of the ARCP / revalidation process, save on Horus ePortfolio and provide a copy to local Foundation Trust Administrator.
- Trusts Local ARCP panels established / convened. 10% of all YHFS ARCPs need to have Lay Rep attendance. Further information around this will be communicated in 2022.
- Foundation Trainees Evidence upload deadline: Horus ePortfolio virtual "Lock Down" for FY1 Trainees
- FTPDs to confirm their availability and attendance at central ARCP panels.

Monday 30th May 2021 to Wednesday 15th June 2022

- Local ARCP Panels to review the Horus ePortfolio and any additional ARCP evidence submitted.
- **FTPD** assigns an ARCP outcome to the trainee via the FY1 ARCP outcome form on Horus ePortfolio.

Please remember that Trusts cannot give adverse outcomes! Only 1s, 5s & 6s

It is recommended that trainees who may potentially receive an adverse outcome (3 or 4) should be reviewed in the Trust in early June and referred to central panel as soon as possible.

If an outcome 5 is awarded, the local ARCP panel must convene again two weeks later to review whether to outstanding competencies have been achieved, if they have, the trainee can be signed off locally, if not, they can be referred to a central ARCP panel for an adverse outcome or discussed with FSD/Deputy. This must be done by the referral deadline – Wednesday 15th June 2022

NB// Dates for period covered on ARCP outcome form is 22/07/2021 to 02/08/2022 - includes 9 days induction/shadowing.

- **Foundation Trainee** to sign the FY1 ARCP outcome form via Horus ePortfolio within **10** working days of the ARCP panel meeting.
- **Foundation Trust Administrators** to advise YHFS when trainees have been signed off locally, so GMC Connect can be updated.

Please discuss trainees with potential adverse outcomes with the FSD / Deputy and advise YHFS by sending the central panel referral form to the generic inbox – foundation.yh@hee.nhs.uk by Wednesday 15th June 2022, so they can be allocated to a central panel.

CENTRAL ARCP - YHFS

- FSD / Deputy to review the local ARCP panel's outcomes and sign the FY1 ARCP outcome form on Horus ePortfolio for those trainees awarded with an Outcome 1 (if satisfied).
- YHFS invites trainees with expected Outcomes 3 or 4 to attend a Central Foundation ARCP panel.

FSD and Deputies to review centrally referred trainees Thursday 16th June

Central Panels - All YHFS trainees: Monday 27th June 2022 - Friday 1st July 2022; 10am till 5pm MS Teams

If a trust is referring a trainee to central panel, a TPD has to be available for the review

SIGN OFF - YHFS

By Monday 11th July 2022 - date TBC with GMC

• YHFS to list completed Attainment of FY1 Competence Certificate (F1CC) for non-home medical school (HYMS / Sheffield / Leeds) and non-UK Medical School trainees and sent to the trainees Foundation School to enable them to sign their F1CC.

Bulk upload July 2021 - date TBC with GMC

• YHFS releases the F1CCs and confirms successful completion of the FY1 year to the GMC

Monday 11th July to Wednesday 20th July 2022

• YHFS - Manual submission of International graduates' certificates to the GMC

Completion deadline Wednesday 20th of July 2022

The GMC cannot guarantee full registration for Wednesday 3rd August 2022 for trainees who submit their F1CC after this date. FY1s cannot work as an FY2 if they have not been signed off.

APPEALS - YHFS

Deadline to appeal ARCP outcome: Friday 15th July 2022

Foundation Trainees wishing to appeal the outcome of the ARCP Panel must do so in writing, to the Postgraduate Dean within **10 working days** after they have received the outcome letters from their ARCP.

Only the process can be subject to an appeal, not the outcome.

Appeals Panel - Wednesday 27th July 2022

- YHFS Appeals Panel covers central ARCPs up to Friday 2nd July ARCP dates.
- Original panel will reconvene to review the process prior to the appeal panel
- Appeal panel to convene **Wednesday 27**th **July 2022**
- Outcome to be communicated to the trainee within 5 working days

(Please note, we appreciate this is a very tight timeframe for the outcome / FY2 start date, but unavoidable.)
