Before completing the full form, you must be able to meet the person specification criteria. If you do not meet the criteria 1 to 14, you are not eligible to apply. Criteria 15 to 19 are desirable but not essential. This is completed at the start of the form. If you do tick yes on this section on MS Forms, you will not be able to complete the rest of the form.

There are 9 sections to the self-assessment form.

Please read each section carefully and refer to the guidance.

You must be able to submit evidence for each section you feel you are eligible for points. You can complete as many or as few sections as you see fit, but the total score will be used to rank all candidates. Ranks will not be published to candidates.

We will only be able to mark the top scoring 250 applicants. (In previous years, we used to interview approximately 160 trainees.) Until we receive our applications, we cannot advise if your application will be reviewed. Once the application window closes, we will advise you whether your application will be reviewed or not.

If we end up in a tie-break situation or have numerous candidates on the same score, in order to give each candidate an individual rank, we will use the following criteria: **Date/Time of application submission.** The earlier submission will be marked as the higher rank.

Evidence can only be used in 1 section of the form.

You cannot be given points for the same piece of evidence in more than one section. You must choose which section will give your evidence the highest score.

YHFS cannot advise which section you should use your evidence for, that is the essence of self-assessment.

This extends beyond the traditional sports activities (football, cricket, netball, swimming, cycling, etc) and includes non-mainstream sports and competitions like (debating, snooker, poker, darts, gymnastics, esports etc) Evidence will only be accepted for events that have taken place after joining university/starting your medical degree.

Section 2: Voluntary work (Maximum 13)

To be eligible for points for sections 2.1 & 2.2, these must be different events. You would need to submit different evidence in order to receive points for both.

Similarly, to be eligible for points for sections 2.3 and 2.4, these must be different events with different pieces of evidence. Evidence will only be accepted for events that have taken place after joining university/starting your medical degree.

- You must provide the dates of tenure in order to be eligible for the points.

- You must provide the dates of tenure in order to be eligible for the points.

You can score points for sections 4.1 OR 4.2 AND 4.3 OR 4.4 as long as you have evidence to support this. Evidence will only be accepted for events that have taken place after joining university/starting your medical degree.

(Distinction/Certificate for having the top exam mark etc.) These points are for extracurricular competitions. Evidence will only be accepted for events that have taken place after joining university/starting your medical degree.

Where an applicant has designed or organised more than one teaching programme, points are only awarded for more than one section if you have evidence to support each teaching programme as a separate event.

You many only claim points if you were actively involved in the teaching session.

For sections 6.1 & 6.2, to claim points for both sections, you must use different evidence.

For sections 6.3 to 6.5, to claim points in each section, you must use different evidence of different teaching programmes or choose the highest scoring section relevant to you.

To be eligible for points in each section, you must have evidence of 5 different teaching programmes. Evidence will only be accepted for events that have taken place after joining university/starting your medical degree.

In this section where an applicant has been involved in more than one project, **points are only** awarded for the project which attracts the highest score. Applicants must be aware that projects used to claim points in this section MUST NOT BE USED be used to claim points in another section of the self-assessment. You must decide which section you want to use your evidence. You are advised to use it in the section that awards you the highest score. Evidence will only be accepted for events that have taken place after joining university/starting your medical degree.

This work should not be part of your course, but an extra-curricular piece of work. If you put more than one score in this section, no points will be added.

Examples of Acceptable Evidence. Evidence not listed may be acceptable if it can be validated.

Section 8: Leadership and management (Maximum Points: 6)

Where an applicant has been involved in more than one leadership or managerial role, **points are only awarded for the role which attracts the highest score.** Applicants must be aware that leadership positions used to claim points in this section **MUST NOT BE USED** be used to claim points in another section of the self-assessment. You must decide which domain you want to use your evidence. You are advised to use it in the section that awards you the highest score. Evidence will only be accepted for events that have taken place after joining university/starting your medical degree.

If you put more than one score in this section, no points will be added.

Section 9: Publications (Maximum Points: 7)

Academic articles must have been accepted in a peer reviewed PubMed indexed journal. Publications should be medical (scientific, clinical, education or leadership) in focus. Where an applicant has more than one publication, points are only awarded for the publication which attracts the highest score. Publication of conference proceeding or abstract is not considered as full peer reviewed publication. Letter to editor will be accepted if original data rather than opinions. Evidence will only be accepted for events that have taken place after joining university/starting your medical degree.

If you put more than one score in this section, no points will be added.

Examples of Acceptable Evidence. Evidence not listed may be acceptable if it can be validated.

 To gain points for a publication, the work must have been published and must have a PubMed ID number (PMID). If there is no PMID, the point will not be awarded. DOI, ISBN or PMCID numbers are not sufficient and will not count.

If the PMID number does not link DIRECTLY to the paper where it can be confirmed that the applicant is an author, it will not gain any points. DIRECTLY means that one click should take the verifier to the page where the required information is listed. Any more than this and the evidence will not be considered.
