The academic component of the FLP is self-directed and you are encouraged to explore and find a course that is most relevant to you (provided there is a leadership or medical education element). Occasionally fellows are already undertaking a postgraduate course related to their specialty and add a leadership module to this as their academic component. It is not mandatory to undertake a PG Certificate, you may wish to explore alternative formal academic courses available.

Below is a list of some courses that previous fellows have accessed. The list is not an exhaustive one. The FLP does not endorse any particular course – we value diversity in the learning experiences enjoyed by fellows.
