### NHS Structure & Finance: A Summary for Fellows

#### **NHS Structure**

The NHS is a large and complex organisation. In 2022-3 Health Education England with merge with NHS England & Improvement, NHS Digital and NHSx to form a single organisation.

#### **NHS Mandate**

The NHS mandate is set on an annual basis by the Department of Health and Social Care, setting the framework of objectives to address health disparities, support leaders and drive innovation

- Continue to lead the NHS in managing the impact of COVID-19 on health and care
- 2. Recover, and maintain delivery of, wider NHS services and functions
- Renew focus on delivering against the NHS Long Term Plan and broader commitments for the NHS
- Embed a population health management approach within local systems, stepping up action to prevent ill health and tackle health disparities
- Ensure effective NHS leadership, culture and use of organisational resource to realise the benefits from future structural changes within health and care



#### How is the NHS financed?

The Department of Health and Social Care spending is projected to be £173.8 billion in 2022/3. This is made up of general taxation, national insurance and patient charges. The majority passes directly to NHS England and the remainder passing to other health related functions such as public health, education and training (including NICE) and the care quality commission (King's Fund)

Some funding is also required for capital investment to maintain the wider NHS estate (King's Fund)
