Academic F2 Post in Palliative Medicine

PLACEMENT

A four month placement with the academic palliative care group based at the Wolfson Palliative Care Research Centre, University of Hull

THE DEPARTMENT

Academic Palliative Medicine is based in the Wolfson Palliative Care Research Centre within the new Allam Medical Building at the University of Hull. The main research interests within the Wolfson Palliative Care Research Centre are assessment & management of under-researched distressing symptoms in advanced disease, inequalities in access to palliative care, patient and family caregiver outcomes in advanced illnesses, and optimising delivery of palliative and end of life care.

These areas of research aim to tackle some of the increasing challenges to providing palliative and end of life care within the health service, as the distribution of age changes towards an older population, and conditions shift from single illnesses to multi-morbidity.

The department has an excellent reputation for international work on breathlessness and palliative care for those with non-cancer conditions (such as heart failure, respiratory disease, kidney failure and primary care based palliative care). The research ranges from epidemiological studies using large datasets, health services research on outcomes and models of care, developing new interventions to manage symptoms, and clinical trials (for instance in breathlessness management). There are strong links to the local clinical palliative care teams, including Dove House Hospice in Hull, St Catherine's Hospice in Scarborough, and to the local NHS hospitals such as the respiratory, cardiology and cancer teams in Castle Hill and Hull Royal Infirmary.

The type of work to expect and learning opportunities

This post will be of interest to those considering a career in a broad range of medical specialities (including palliative medicine, gerontology, primary care and public health) but would also be useful to those interested in health services research and epidemiology, especially as it relates to the ageing population.

The health services research project will be planned in discussion with the trainee and the supervisors. Examples of potential projects for academic F2 trainees include secondary analysis of existing qualitative and quantitative datasets, systematic reviews, and contribution to components of existing studies.

The post will provide exposure to clinical and translational research which it is expected will lead to a communication (case or short report, abstract and presentation at a scientific meeting or similar).
