

Summary of Changes to SOPs 24-25

National SOPs

During the meeting the Directorate responsible for the review of the national SOP will be asked for a brief update on any changes made to the national SOP. Each Directorate will be asked to confirm they can comply with the SOP during the meeting.

- Principles for ARCP and ARCP Appeals (no local SOP) Primary Care
 - No changes identified to the national SOP
- Management of Fellows (no local SOP) LSFD
 - No changes identified to the national SOP
- Rotational Management (no local SOP) STP
 - Noted that late recruitment is no longer an exception to Code of Practice, this will need to be considered when reporting compliance – will feedback to EDs when they ask for feedback
- NTN Withdrawal (local SOP pending) Revalidation
 - No changes identified to the national SOP
- Educator Development (no local SOP) LSFD
 - No changes identified to the national SOP
- Professional Support (no local SOP) LSFD
 - No changes identified to the national SOP, noted this SOP does not cover the work we do on Neurodiversity
- Quality Reporting (no local SOP) Quality
 - No changes identified to the national SOP

- Revalidation (no local SOP) Revalidation
 - No changes identified to the national SOP
- Complaints (no local SOP) Revalidation

OOP – STP

Lay Representatives - PMO

- > No national changes made other than confirmation of recruitment via TRAC
- Local SOP changes include
 - Feedback form should be an MS Forms rather than a Word document
 - The ARCP Panel Chair Checklist Form should be amended to include two questions, one to ask if they had a lay rep on the panel and the second to ask for feedback on the lay rep
 - Change to require lay reps attend 5 events per year as a minimum
 - Added a section on booking a lay rep

Acting Up - STP

No national SOP change

Period of Grace – Dentistry

- > Further clarification re: when a PGDiT is eligible to apply for a consultant post
- > Explicitly states that NTN is retained during POG

Updated references to GG to v10

ARCP Appeals - Revalidation

- Added outcome 10s to reflect GG
- > Amended the reference to schools managing appeals to Revalidation
- Minor change to the composition of the panel to reflect the Gold Guide v10

Inter-Deanery Transfer (IDT) YH SOP - PMO

- > There is no national SOP, but the local SOP is due for review
- Group agreed to change the HoS (or nominated deputy) is responsible for signing off all vacancy declarations made by the TPDs

To be reviewed in March 2025

- Local Less Than Full Time Training STP
 - National SOP no changes and our process align with the SOP
- Local ARCP Operational Guidance Foundation
